#### **Security**



First substantive meeting of Open-Ended Working Group takes place in New York

Europe should consider a 'digital border control', says Deutsche Telekom's cybersecurity division head

Cybercrime cases continue: Wikipedia fights off huge DDoS attack; Ecuador to investigate data breach of up to 20 million people; one in three youth is a victim of online bullying (UNICEF poll)

## New technologies (IoT, AI, etc.)



At least 75 countries use AI surveillance technology, report finds, while China will impose obligations for AI algorithms to promote 'mainstream values'. US Air Force publishes AI strategy

UK court rules facial recognition use by police lawful, while Moroccan data protection authority announces temporary facial-recognition ban. Facebook introduces changes to its facial recognition settings, giving users more control
